DISCUSS TRUSTEE ITEMS

Member Ray mentioned that the District would be doing an update presentation at a June meeting for the Town of Yountville. Member Ray and District Manager, Wesley Maffei, to confirm date and time.

MANAGER'S REPORT

- The District completed 17 service calls for the month of March. The District continues to do morning check-ins with staff and follow best-practice sanitary and social distancing guidelines.
- 66 low-cost housing units are being built in the vacant lot immediately adjacent to the District which will create a shared driveway. To enhance District security a magnetic gate locking system will be added, roll down doors will be added to all the carports and barbed wire will be added to the fencing at the District.
- District Manager noted Assembly Bill 2932, creating a 32-hour work week, is currently generating discussion with legislators in Sacramento.
- The Manager continues to work on District's PEIR update and has provided 3 sections for review to District's counsel.
- The District will participate in this year's Napa Valley Home and Garden Show, a three-day event to be held in Napa from April 22 to April 24, 2022
- District ads with the Napa Valley Register and its affiliates have been renewed for another year.
