# MANAGER'S REPORT

- -The District completed 4 service calls for the month of February. The District technicians have been proactively pre-treating various sites. Solano County Mosquito District has breeding sites adjacent to Napa County line; they have fogged the area and the District is checking results of treatment. Treehole season is fast approaching.
- -District has a new Hold Harmless Agreement form for the 2019 Treehole Fogging season. The new form has been reviewed and modified by District Counsel. District Manager states that with new language additional liability risk has been placed on the District.
- -The District has continued its advertising in the County's newspapers.
- -Peter Ozorio, District Operations Supervisor, gave a presentation and overview on MapVision software.
- -Wesley Maffei, District Manager and Alicia Hinojoza, Administrative Assistant attended the Vector Control Joint Powers Authority (VCJPA) annual workshop. Wesley Maffei is currently the Treasurer on the VCJPA board.
- -District Manager continues to attend the Wetlands Regional Management Workshops. March 21<sup>st</sup> is the next scheduled meeting; the topic is mosquitoes and the District Manager will be giving two presentations.
