QUARTERLY INVESTMENT REPORT FOR 1st QUARTER ENDED SEPTEMBER 30, 2021

The CalPERS OPEB account earned \$14,684 in interest for the quarter ended September 30, 2021. Funds held with PARS earned negative interest of -\$5,277. The VCJPA Member Contingency Fund did not have interest posted at the time of this report. No action required.
