MANAGER'S REPORT

- -There were 86 service calls for the month of July.
- -The District Manager is working with an actuary to complete the required GASB68 and GASB75 reports.
- -The District Manager is working with the San Francisco Estuary Institute to provide information and data on invertebrates that may serve as bio-indicators of tidal marsh conditions.
- -The District is seeking a permit from California Fish and Wildlife for its source reduction work in tidal marshes.
- -In reference to recent controversy surrounding President Trump, the US Court of Appeals issued a ruling that a Public Official blocking commenters/users on Twitter is a violation of the 1st Amendment. The District Manager noted that due to the sometimes volatile environment surrounding mosquito district activities this was another reason for the District to be careful with its social media footprint.
- -The District contacted various schools within Napa Valley Unified to proactively check for and treat wasp nests before the start of the new school year.
- -Board members received via US Mail an optional questionnaire from a member of the San Mateo Mosquito and Vector Control District regarding their knowledge of the Mosquito and Vector Control Association of California Trustee Advisory Council.
- -Peter Ozorio, District Field Operations Supervisor, briefly spoke about his recent presentation to elementary aged children at Bothe State Park as part of the Nature Summer Camp program. Peter expressed his gratitude and excitement to return in future years.
